As a **Keeper Camp** participant at Utah's Hogle Zoo, it is required that you have a tuberculosis skin test. The results of the test should be returned to the Program Coordinator **2 weeks prior to your camp date** for approval. To successfully complete this requirement, we suggest the following:

1. We prefer that you have your test administered by the Salt Lake City-County Health Department. (Please call to confirm their schedule of testing days and times). If you have your personal physician administer the test, please have them fill out this form completely. The test must be read by the doctor/nurse practitioner, not self-read.
2. Complete the personal information requested below and have your physician or the public health nurse complete the portion of this form dealing with the test results. **All items in bold are required.**
3. Return this form to the Program Coordinator at Utah's Hogle Zoo. We recommend that you keep a copy of this form for your own records. Any other paperwork you may receive you may also keep for your records.
